7. PROVIDER agrees and declares that he/she has no expectation of receiving any compensation, financial benefit, or reimbursement of any kind from RECIPIENT for providing gratuitous services under this agreement.

8. PROVIDER agrees to make no claim for compensation, financial benefit, or reimbursement of any kind against RECIPIENT for gratuitous services provided under this agreement.

9. PROVIDER understands and agrees that it would be unlawful for RECIPIENT to accept PROVIDER services if PROVIDER had any expectation of any compensation, financial benefit, or reimbursement from RECIPIENT

10. Both parties declare that this document constitutes the sole and complete gratuitous services agreement between them.

11. Any future, extended or continued work or services will be created under a different agreement.

If you are receiving this document, you are receiving a gift, discount, matching of funds or some form of extra support and/or sponsorship for your project.

### PRIVACY

I ask that the reduction is kept private. I add the full fees to the top of the invoice to showcase what the normal cost would be if you choose to share or reference. My prices and gifting are based on each individual project. To share that I have been generous is fine, but I do not like the numbers to be shared.

### ACCOUNTABILITY AND EXPECTATIONS

Regardless of the size of the project and time of a project, once you pay your gifted and discounted amount, I honorably place you under the contract of anyone paying a full fee.

That means...

- regardless of what you pay, you are served and stewarded as a full price client.
- NEVER feel like you can not ask questions like a full paying client.
- A 10K project is treated with the same honor as a 100K project.

### COMMUNICATION

If you send an email, text or attachment and you have not received a response within 24 hours during a week day or not heard back on Monday by noon, send again.

### DO NOT WAIT!

Sometimes emails get lost, phone messages get erased. PLEASE, NEVER assume, I or my team are busy with other projects and we will get back to you when we can.
